PRESIDENT'S MESSAGE

Dear Members:,

The board members of the Texas Association for Interior Design have been hard at work to protect the interests of interior designers in Texas. Since our big reception for the state legislature in late January, members of the TAID board have made trips to the Capitol a number of times in order to visit with legislators about our bill. The Interior Design Practice Act (House bill, HB 1985 and Senate bill, SB 832) has been moving slowly, but steadily, through the legislative process. We have experienced both frustration and elation while watching our bill make its progress. We are happy to report that the bill should soon be going to the House of Representatives for a vote, carrying a grandfathering clause that will be good for all currently registered interior designers. Although we can not know how the wording of the bill might change as it moves through different legislative committees, it now acknowledges designers with long experience in our profession. The bill states that an interior designer who has not passed the NCIDQ exam must:

- 1. Pass section one of the NCIDQ (Building & Barrier Free Codes section) AND complete, in addition to the 8 hours of yearly required continuing education, 15 hours of board approved continuing education classes relating to building and barrier free codes and egulations.
- Or 2. Demonstrate 25 years of board approved interior design experience AND complete, in addition to the 8 hours of yearly required continuing education, 15 hours of board approved continuing education classes relating to building and barrier free codes and regulations
- Or 3. Have passed the examination required for registration as an architect

Designers would have until September 1, 2011 to fulfill these requirements.

There are other bills affecting interior designers that TAID has been watching during this legislative session. One of the bills is HB 1038 relating to the TRCC (Texas Residential Construction Commission). A number of designers have been caught in the middle of doing work as an interior designer and being labeled as a builder/contractor, thus having to pay fees to another agency in addition to paying fees to the agency that regulates interior designers, the Texas Board of Architectural Examiners (TBAE). TAID was successful with having an amendment added to this bill that exempts interior designers, if they are doing interior design work as defined by the TBAE. This amendment has passed the vote in the House and now will go to the Senate for consideration.

Many designers have been helping during this legislative session by emailing to their legislators and asking them to support our Practice Act bill. By the time you are reading this newsletter, I hope our bill has made it to the Senate. To know the status of our bill, go to www.legis.state.tx.us and then you put in the bill number (HB 1985 or SB 832). Just email them with a simple request to support our bill (in the House it is HB1985 and in the Senate it is SB832).

Executive Director News

It is that time of year again when TAID is working round the clock. We are watching many bills this year that might have an impact on the interior design industry in Texas.

The House spent many hours debating the best way to reform the controversial Texas Residential Construction Commission (TRCC). Created four years ago, the agency is meant to help the buyers of new homes resolve differences with home builders. This session, Rep. Allan Ritter (D-Nederland) is carrying H.B. 1038 to give the TRCC more "teeth."

This legislation gives the TRCC the authority to discipline builders who do not register as required with the agency, if they repeatedly fail to make an offer to repair a home, or if they do not "reasonable perform on an accepted offer to repair a building defect based on a third-party's recommendation or an appeal." Builders would also have to take five hours of continuing education courses each year.

If passed, the TRCC would also have the ability to issue cease and desist orders against builders violating the Act.

We were successful in having "registered interior designers" listed as an exemption.*

Sen. Troy Fraser (R-Marble Falls) is expected to sponsor the legislation in the Senate.

*Now to clarify what this exemption means. It does not mean that a registered interior designer can do residential construction. It does mean that you will be exempted from performing services that are done by interior designers in the normal routine daily practice of an interior designer. Examples are replacing carpet, wallpaper, draperies, etc.

Guide to Texas Legislative Information - DATES OF INTEREST CONT.

Midnight deadline for senate to print and distribute all conference committee reports on bills other than tax, general appropriations, and reapportionment bills and all house amendments to Senate bills that did not go to a conference committee

[relates to Senate Rule 12.09(b) and Senate Rule 7.21, requiring 24-hour layout of certain conference committee reports and house amendments to senate bills during the last 72 hours of a regular session]

Sunday, May 27, 2007 (139th day)

Last day for house to adopt conference committee reports [House Rule 8, Sec. 13(e)]

Last day for senate to concur in house amendments or adopt conference committee reports

[relates to Senate Rule 7.25, limiting a vote on the passage of any bill during the last 24 hours of the session to correct an error in the bill]

Monday, May 28, 2007 (140th day)

Last day of 80th Regular Session; corrections only in house and senate

[Sec. 24(b), Art. III, Texas Constitution]

Sunday, June 17, 2007 (20th day following final adjournment)

Last day governor can sign or veto bills passed during the previous legislative session

Q&A with TBAE

Q: I heard that the process for renewing my TBAE registration will be different. Is that true?

A: It's true, and renewal will be easier and quicker than ever. Later this year, TBAE will no longer mail out the printed renewal notice you probably received in past years. There's nothing to fill out, no need to write out a check, no stamps, and no trip out to the mailbox or Post Office.

Q: So how do I renew my registration, then?

A: Renew online at www.tbae.state.tx.us. Just log in to your account and click "Renew My Registration." Then it's quick and simple to renew online with your credit card or an automatic draft from your checking account.

And while you're at it, you can check to ensure your mailing address, email address, and other information is still valid. (We need your contact information to deliver news, updates, and important information about your registration.)

Q: Is there anything else changing about my registration?

A: Yes—your registration fee will be reduced! Because TBAE has become more efficient and effective in its operations, the board was able to vote to reduce registration fees, effective September 1 of this year. It is precisely such efficiency-enhancing developments as online renewals that allow TBAE to reduce registration fees.

The fee reduction will weigh in at about \$5 per registration, and must be finally adopted during the board's meeting in June.
