## PRESIDENT'S MESSAGE

Dear Members:,

With the beginning of my term as president of TAID we are also seeing the convening of the 80th Texas Legislature. During this session TAID will again be submitting the bill for an Interior Design Practice Act. As always, we have high hopes for success, but the support of interior designers from all across Texas makes the passing of the Practice Act much closer to a reality.

ASID, IIDA and unaffiliated interior designers are working together to educate our state legislators on how interior designers' decisions affect the life safety of the public. On January 30th many interior designers gathered at the Capitol to visit each state representative's and each state



senator's office, asking for their support of our Practice Act. The Governor signed a proclamation (see page 8), declaring January 30th as Interior Design Day in Texas. That same evening, TAID hosted a reception for the entire state legislature at the Driskill Hotel, a historical hotel within walking distance of the Capitol.

If you were not able to make it to Austin for Interior Design Legislative Day, you can still help with getting our bill passed. You can write a letter, and send by mail or fax, to your representative and your senator asking for their support. We want them to know that an interior designer makes decisions that affect the health, safety, and welfare of the public. We would like our bill passed so that code regulated spaces can be designed by only licensed interior designers, who are required to have an accredited education, an exam, and work experience. We could also assure the legislators that our bill exempts architects.

As I am writing this, our bill for a Practice Act has not been filed with the 80th State Legislature. That means at this point we do not have a bill number that I can give you to refer to when you write your legislator. Please check the TAID website, <a href="www.supporttaid.org">www.supporttaid.org</a>, because as soon as we have a bill number, it will be posted on our site. If you are unsure who your representative and senator are you can go to <a href="www.capitol.state.tx.us">www.capitol.state.tx.us</a>, and under "who represents me" you can give your address to find your legislators.

With all of us working together we can insure a secure future for interior design, raising the quality of our profession.

## **TBAE News**

#### (TEXAS BOARD OF ARCHITECTURAL EXAMINERS)

**Question:** My certificate of registration will soon expire and I have discovered that I have not earned enough continuing education credits. I know that I cannot renew my registration unless I attest that I have fulfilled the mandatory continuing education requirements. Should I indicate that I fulfilled my continuing education requirement and earn the credits after the renewal of my certificate of registration?

**Answer:** No. You should never submit false information to TBAE – about continuing education or anything else. Knowingly acting to deceive the agency is a much more serious matter than failure to fulfill continuing education requirements. Falsifying continuing education reports may result in an administrative or criminal sanction.

Since you cannot renew your certificate of registration without attesting that you have earned the required continuing education credits and you will lose the right to practice architecture or represent yourself as an architect upon the expiration of your registration, you may feel you are stuck in a Catch 22 --you will be subject to adverse action regardless of the direction you take. However, you may be surprised to find that there are ample continuing education opportunities on the Internet. For example, you may fulfill your educational credit in barrier-free design by studying the Texas Accessibility Standards online. Three hours of continuing education credit may be earned through self-directed study. Do not assume it is too late to fulfill the continuing education requirements.

As an absolute last resort, you may change your certificate of registration from "active" to "inactive" status before it expires. Because inactive registrants are exempt from the continuing education requirements, you may then renew your inactive registration without certifying that you have fulfilled the continuing education requirements. After you have earned the continuing education credits, you may then return your registration status to active at which time you may truthfully report your compliance with continuing education requirements. You may not engage in the practice of architecture or represent yourself as an architect while your registration is on inactive status. This option will require you to pay a fee to change your registration status to inactive and pay another fee to return your registration to active status. In addition, temporarily terminating your practice and losing the use of your title would obviously pose a significant inconvenience and disrupt your business.

It is in your best interest to simply earn your continuing educations credits throughout the year and maintain a record documenting that you have done so. You are more likely to find quality and relevant training if you are not in a panic in the last days before your registration expires. Obtaining continuing education is good for your practice and secures the health, safety, and welfare of the public.

He has been a mentor to me. This is a loss to the design community nationally."
